Nominations and Elections Timelines

September 1, 2018 – December 14, 2018 – Petitions for VEA-R Council and for Delegates/Alternates to the NEA and VEA conventions are available upon request from the VEA by writing the VEA (at the address above) or by e-mail request to Barbara Rackley at brackley@veanea.org.

Nominations open (by petition) for:

- VEA-R Secretary/Treasurer (3-year term, 08/01/19 – 07/31/22)
- VEA-R Council Congressional Seats – 1, 3, 5, 7, 9, & 11 (3-year term, 08/01/19 – 07/31/22)
- VEA-R Council Congressional Seat – 2 (1-year term, 08/01/19 – 07/31/20)

September 1, 2018 – December 14, 2018 – Nominations open (self-nominated) for delegates and alternates to:

- VEA Delegate Assembly (March 28 – March 30, 2018) in Richmond, VA
 - NEA Representative Assembly (July 2 – July 7, 2018) in Houston, TX
- A completed **self-nomination form**, along with a **typed, half-page biographical statement** must be returned to the VEA postmarked, hand-delivered, or e-mailed no later than December 14, 2018.

Election information will be sent in the VEA-R newsletter to all VEA/NEA Retired members and details will also be posted on the VEA-R web site on when and how to vote.

December 14, 2018 – Deadline for submission of petitions and the self-nomination form. Petitions and self-nomination forms must include a typed, **half-page biographical statement**. The petitions, forms, and biographical information must be returned to the VEA office – post-marked, hand-delivered, or e-mailed to Barbara Rackley at brackley@veanea.org – **on or before** December 14, 2018.

Any nominations postmarked, hand-delivered, or e-mailed, after December 14, 2018 will not be accepted.

January 23 – 25, 2019 – Electronic voting by members. Voting begins at 12:00 p.m. (noon) on 01/23/19 and ends at 12:00 p.m. (noon) 01/25/19. Voters may use **any** personal computer or device that has Internet accessibility. Voters who do not have a computer/device may go to a library or other locations that have public Internet accessibility. Contact brackley@veanea.org to request a paper ballot. All paper ballot requests must be received by 01/02/19. Paper ballots will be mailed on 01/04/19. All paper ballots must be postmarked or hand delivered to the VEA office by the close of business on January 22, 2019 to be counted.

January 28, 2019 – VEA-Retired Elections Committee certifies election results.

February 1, 2019 – Candidates will be notified by telephone and in writing and/or e-mail of the election results. The election results will also be posted on the VEA-R web site.

March 1, 2019 – VEA Delegate Assembly housing reservations will be made online directly with the assigned hotel and must be made no later than March 1, 2019. A link for making the reservation will be provided to the successful candidates. **Note:** Delegates to the NEA Representative Assembly will be sent housing reservation information closer to the NEA convention deadline.
